# **FULAFOAM CLEANER**

## Description

Fulafoam Cleaner is a solvent based cleaner for cleaning uncured or fresh polyurethane from applicator guns, tools and other surfaces. Fulafoam Cleaner can be used to clean applicator guns used for Fulafoam PRO Standard, Fulafoam Flexible and maxbond PRO gun-applied foams and adhesives. Fulafoam Cleaner is formulated to be free of ozone depleting propellants.

### **Benefits**

- Does not contain CFC's and H-CFC's
- Rapid cleaning of uncured polyurethane

#### Uses

- · Cleaning of HB Fuller applicator guns
- Clean up of excess foam or foam adhesive from tools and work surfaces, window frames, window sills, doors, door jambs etc

#### Yield

One can of Fulafoam Cleaner will be sufficient to clean multiple guns. Cleaning of the gun is not required after every can of foam or adhesive is emptied, however, cleaning every 10-20 canisters is recommended, or more often if only intermittent use of the gun is performed. If the gun will be stored without a canister attached then the gun should be cleaned to prevent and residual polyurethane from jamming the application mechanism

## **Application**

#### IMPORTANT:

Fulafoam Cleaner contains flammable solvents. Do not smoke or work near any sources of ignition such as naked flames or anything that may generate a spark or high temperature. Shake can at least 20 times before each use to ensure that contents are mixed. For hand cleaning of surfaces or tools attach the red nozzle to the can and gently depress the nozzle. For cleaning of a gun applicator attach the canister to the gun by removing the red nozzle and aligning the thread on the canister and gun and turn until locked in position. To clean the gun open the screw valve at the rear or the gun and gently press trigger to release foam. The rate of extrusion can be varied, by turning the screw thread at the rear of the gun. When gun has been cleaned close the valve at the rear of the gun and remove the canister. Re-open the valve and press the trigger to depressurize the gun. Note: a significant amount of residual cleaner will still be contained in the gun before depressurization so ensure gun is pointed away from anyone before pulling the trigger.

# Clean Up

Surfaces surrounding the job area should be protected from accidental contact with Fulafoam Cleaner. Clean up dissolved foam with a rag.

## **Shelf Life**

Twelve months unopened from date of manufacture. If open and is attached to gun, will remain useable for up to 6 weeks.
